On the 27th day of July, 2008 at 3:29 A.M. P.M. (Specifically include facts constituting cause for arrest)

On Sunday July 27th, 2008 at approximately 0258 hours I responded to The Dollar Place, located at 1695 W Indiantown Rd [REDACTED]. Upon arrival, I approached the building from the southeast side. Upon coming into view of the business, I noticed the front glass door of the business swaying back and forth. I then observed a male subject step into the doorway of the business. The subject was a black male, and was wearing a light colored shirt and dark colored shorts. The male was facing westbound and stopped in the doorway. I immediately requested that Jupiter Police Communications Officers give me emergency traffic. Immediately after my radio transmission, the male turned and began to run westbound from the doorway.


I identified myself as a Jupiter Police Officer and was wearing a Jupiter Police uniform. I ordered the subject to stop. I pursued the subject on foot, following him westbound, and behind a separate building in the same shopping plaza. Upon reaching the rear of the building, the suspect then proceeded to run southbound down the alleyway on the west side of the stores. Upon reaching the end of the building, a wall which runs behind the building ended, where the subject turned back northwest into a wooded area west of the shopping plaza. I stopped following the suspect and waited outside the wooded area for other units and K9 to arrive. I heard branches snapping and leaves rustling inside the wooded area, and the sounds appeared to be getting further away towards the north. K9 Officer Fronrath arrived and as I was explaining the situation, I witnessed the same male subject jump over a wall on the west side of the original location. He proceeded to run eastbound behind the Dollar Place. Sgt. Lunsford had arrived on the east side of the business and saw the suspect jump over a wall separating the shopping plaza with the Simms Creek residential development. A track was initiated from the point the subject jumped the wall. K9 Officer Fronrath and K9 Titan performed a strong track which led to a property located at 110 N Delaware Blvd #18B. A subject, later identified as the defendant Rodney J Allen was apprehended at this location. (See associated report by Officer Fronrath).


A vehicle was located nearby bearing FL tag C654SF. The vehicle was parked on the west side of Nick's Tomato Pie, located at 1697 W Indiantown Road. An identification card with the defendants name was located on the passenger seat of the vehicle. The vehicle was registered to another male who was unable to be located or contacted. The vehicle was towed pending an investigation by crime scene technicians.

The interior of the business was checked by K9 Officer Fronrath and K9 Titan with negative results for additional subjects. The method of entry appeared to be a door on the west end of the building. There were pry marks around the lock mechanism of the door and the deadbolt was found lying on the ground in front of the door. A large shelf was knocked over as the suspects gained entry into the building. Nothing else was disturbed in the main room of the store. The door to an office in the northeast corner of the building had a large hole in the center next to the door handle. The hole was used to unlock the office door in order to gain entry. [REDACTED]

The [REDACTED] business was processed for DNA samples; [REDACTED]

Photographs were taken of the scene and were submitted into evidence. The defendant was read his Miranda warnings and stated he understood them and advised he would answer questions. The defendants only statements were that he was homeless and that he had nothing to do with any burglary.
