On the 11th day of September 2009 at 11:00 X AM PM (specifically include facts constitution cause for arrest)


On 08/14/2009, Officer B. Rhodes was dispatched to Jupiter Pavilion Convalescent Center, 1230 South Old Dixie Hwy, # 218A, Jupiter, regarding a suspicious incident in which a patient, **Bruce Garwood, w/m 02/11/1935**, was reported to have child pornography on his laptop computer. The suspect, Bruce Garwood was a registered patient and another occupant's family member witnessed the images. Garwood provided the Dell laptop 6HG6TG1 computer to Officer Rhodes with knowledge of the allegation. He stated that he teaches dance to a group of Boy Scouts in Tequesta and has several pictures of dance practices. Garwood signed a consent form and was advised that he had the right to refuse the search. The computer was placed into the Jupiter Police Department evidence.

On 09/10/2009, I transported the aforementioned Dell computer to the Palm Beach County Sheriff's Office and met with Detective Patrick Paige. Detective Paige is an investigator in the computer forensics unit and agreed to conduct an examination and image the hard drive of the computer.

On 09/11/2009, I was notified by Detective Paige that he imaged the laptop computer and found an image of a young white prepubescent male posing naked sitting upright with his erect penis in his hand. In addition there were nine (9) photographs of child erotica wherein young boys were standing, sitting, or laying while entirely naked.

On 09/15/2009, at approximately 10:00 A.M., Officer B. Rhodes and I met with Bruce Garwood in his room at the Jupiter Pavilion Convalescent Center, room #218A. which is an assisted living facility. Mr. Garwood is physically handicapped and requires the use of a wheelchair for mobility.

I commenced a tape recorded interview, at which time Garwood advised 



Garwood admitted t

This investigation revealed that Bruce Garwood did knowingly and willfully possess, distribute, transmit, receive and or manufacture images of child pornography as well as child erotica on his Dell laptop computer as the image depicted is a prepubescent minor engaged in sexual conduct, in violation of Possession of Computer Pornography Florida State Statute 847.0135 (2)(d).
