On 04/24/09, Officer Ercolano responded with DCF Investigator Nick Blyer to Jupiter Christian School in reference to a complaint that a teacher, Geneva Henry (09/28/79), had been sending inappropriate text messages to fourteen year old student [REDACTED]. I was assigned this case for further investigation. Officer Ercolano met with the one of the principals of the school, Bill Vorlicky who advised that an anonymous student reported the incident on Saturday April 11th, 2009, and that on Monday April 13th, 2009, members of the staff confirmed with the victim [REDACTED] that the text messages were sent and were inappropriate. They also spoke with Henry on April 13th, 2009, and she asked to resign, as she conceded that she had sent inappropriate text messages to [REDACTED].

On 04/29/09, I met with [REDACTED] at his home at [REDACTED] in [REDACTED]. I conducted a taped interview with [REDACTED] while his father [REDACTED] was present. [REDACTED] advised that he is currently a freshman at Jupiter Christian School, and that he was a student in Henry's English class this year. He advised that he began speaking frequently with Henry during class and after class as she is a young teacher and he felt as though he could talk about anything with her. He advised that a short time before Christmas in 2008, he began to speak to Henry on the MySpace website. He advised that he had saved some of the messages from Henry to him that he had received on MySpace. He showed me the messages and then cut and pasted the messages onto a WORD document and emailed them to me. The conversations between the two were of a personal nature.

[REDACTED] also advised that Henry had written about six poems about him, which she had shown to him. He advised that he had taken one home. He looked for the poem at home, but advised that he must have given it back to her as he did not have it anymore. He advised that the poems stated that Henry got butterflies in her stomach whenever he walked by.

[REDACTED] advised me that about two months ago, he began to receive inappropriate text messages from Henry that were of a sexual nature. When asked if he could recall the content of any of the messages, he advised that he remembered that one specifically stated "I want to rip all of your clothes off and have sex with you to the point of ecstasy" and another said "I want to kiss you all over". He advised that a lot of the messages were just that she wanted to have sex with him. [REDACTED] advised that she would sometimes text "so?????" after the sexual advances, and he would either not respond or just respond "k". [REDACTED] advised that on a what he believed was a Wednesday night, he received a text message from Henry asking if he could meet with her and that she would come pick him up. On another occasion, she texted [REDACTED] that she had really wanted to get together with him over the weekend, and he told her that he had been at the movies with his friends. [REDACTED] advised that many of these messages were done during school hours.

[REDACTED] advised that Henry had come by his house on two occasions. On one occasion, she was dropping off a bag of clothing that [REDACTED] had left in the classroom after a community service outing. On another occasion, she brought by two girls from school that wanted to see [REDACTED]. [REDACTED] advised that the girls were [REDACTED] and [REDACTED]. He advised that Henry never got out of the vehicle on either occasion. [REDACTED] advised that Henry drove a red minivan. It should be noted that Henry has a red Toyota minivan registered in her name.

[REDACTED] had also advised that Henry had told him that she had cheated on her husband on two occasions. [REDACTED] advised that he showed his friend [REDACTED] the messages that Henry had sent to him. He had spoken to [REDACTED] about the situation with Henry as well. [REDACTED] also advised that Henry had shown another student, Byron Dames the text messages that she had sent to [REDACTED], as she had told him that she had shown the messages to Byron. [REDACTED] advised that he does not know how the information about his relationship with Henry had gotten back to the school. His father [REDACTED] advised that the school administrators told them that an anonymous student had told them about the relationship.

█████ advised that the last message that he received from Henry was on the Friday before she was fired. He advised that she was mad at him because he was flirting with another girl. She sent him a text message telling him that she hoped that the girl was worth it. █████ advised that he had never had any sexual contact with Henry. He advised that she had hugged him on a few occasions, and that the hugs were the only physical contact that they had together.

I then interviewed ████████████████████ at ██████ home. ██████ advised that he knew that ██████ and Henry had been talking for a while via text message and by phone one time. He advised that he knew that Henry had a MySpace page, and he assumed that they were talking on MySpace as well. ██████ advised that he does not attend Jupiter Christian, but that he and ██████ are very good friends. He advised that he too had spoken to Henry by text message but nothing that they said was ever sexual. ██████ advised that he had asked Henry about the text messages that she had sent to ██████, and she told him that she there was nothing going on, and that she would not jeopardize her job. ██████ advised that he did see some text messages that Henry had sent to ██████, but did not recall exactly what they said. He did advise that ██████ told him about the fact that Henry had wanted to have sex with him, and asked to speak to ██████ about the situation. ██████ also advised that ██████ and ████████████████████ had told him about the time that Henry had taken ████████████████████ and ████████████████████ to ██████ and ████████████████████ neighborhood. ██████ advised that he believed that ██████ had been propositioned by Henry based on the conversations that he had with both ██████ and Henry.



On 04/30/09, Detective Kelly Sanders and I met with the administrators of Jupiter Christian School to obtain taped statements from them in reference to this incident. I first interviewed one of the principals of the school, Rachel Sanders. Sanders advised on 04/11/09, she received a call from Tim Holland, one the schools vice principals, who told her that he had received a call from a student who wished to remain anonymous, who told Holland that he had seen text messages sent from Henry to ██████ stating that she wanted to have sex with him. Sanders was present during the interview with the anonymous student. That student advised that he had seen text messages from Henry to ██████ advising that she wanted to have sex with him. Sanders advised that on 04/13/09, she, Holland and the Headmaster of the school, Leslie Downs, met with ██████ and his mother ████████████████████ to speak to them about the situation. Sanders advised that at first, ██████ denied that there was any inappropriate text messages sent to him from Henry. After Sanders advised him that they knew what was going on, and that he had to tell the truth, ██████ did advise that Henry had sent him text messages asking him to have sex with her. He told them that there was no physical relationship between them other than hugging.

Sanders advised that after the meeting with ██████ and ████████████████████, they called Henry, and she came in to meet with Sanders, Holland and Downs at the school. Sanders advised that when she asked Henry if she had sent any text messages telling ██████ that she wanted to have sex with him, she denied it and advised that someone had taken her phone and sent the messages. Sanders asked her why she did not report the theft of her phone, and Henry then asked to speak to Sanders alone. Sanders advised that she was alone with Henry for a few minutes, and during that time, she asked Sanders what she should do, and Sanders told her that she needed to tell the truth and do the right thing. Sanders advised that Holland and Downs returned, and Henry then told Downs that she wanted to resign because she had inappropriate communications with a student.

I also interviewed both Holland and Downs, and they gave the same account of the incident as Sanders. On 05/01/09, I interviewed Byron Dames (04/20/90). Byron advised that he had been talking to Henry, and she began speaking about ██████ and how he wanted to smoke, and that she wanted Byron to talk to him about not smoking. Byron advised that she continued to speak about ██████, and about the fact that he plays games with her like leaving his stuff at school so she has to bring it to him. Byron advised that he told Henry that if ██████ was not fourteen, he would think that she had a thing for him. Byron advised that initially, Henry told him that there was nothing going on, but when he pressed her, she admitted that she had a crush on ██████. Byron advised that Henry told him that she had been sending ██████ text messages. He advised that she showed him some of the text messages that she had sent to ██████. Byron recalled that one of the messages that he saw on her phone to ██████ stated "I want to have sex with you". Byron advised that Henry asked her to try to talk to ██████ and get him to have sex with her. Byron stated that he told Henry that he lives in a guest house by himself, and Henry asked him if she and ██████ could use the house. Byron went on to advise that ██████ had spoken to him about the fact that Henry wanted to have sex with him, and he stated that he told him not to do it. Byron advised that he later told Holland and Sanders about the text messages that he had seen on Henry's cell phone to ██████.

On 05/01/09, Detective Kelly Sanders and I went to Henry's home at 737 Cinnamon Road in North Palm Beach to interview her about the incident. She advised that before she made a statement to me, she wanted to have her husband present, so she called him at work and asked him to come home. While her husband was en route, Henry told me that she was presently being treated for [REDACTED], and that was the reason why she was acting the way she did with [REDACTED]. Henry advised that she did tell the administration of Jupiter Christian School that she had engaged in inappropriate communications with [REDACTED], but would not expand or specify what she said to him. Henry decided not to give a taped statement at that time, but advised that she would turn herself into me after consulting with an attorney.

Based on my above described investigation, I am charging Geneva Henry (09/28/79) with **Lewd and Lascivious Conduct**, as she did solicit [REDACTED] to commit a lewd or lascivious act, by text messaging him on several occasions that she wanted to have sex with him, contrary to **Florida Statute 800.04(6)(a)and(b)**.
