## Town Council & CRA Corner: Recent Policy Actions

Below is a summary of some of the approvals and decisions made by the Town Council during recent meetings. ### TOWN COUNCIL

- **Fisherman's Wharf:** Approved a change in land use from mixed-use to commercial on the 4.4-acre property on the north side of East Indiantown Road immediately west of the Intracoastal Waterway.
- **Landscaping and Irrigation Maintenance Contract:** Awarded a contract for \$973,282 to Terracon Services, Inc. for landscaping and irrigation maintenance services for Town facilities, the Riverwalk and various roadway medians.
- **Collector Roadway Lighting:** Awarded a contract for \$166,064 to Lazarus Group, Inc. for lighting on Toney Penna Drive and Bush Road. The contract is for labor to install under pavement and underground electrical conduit and electrical junction boxes with project materials supplied by Florida Power and Light.
- **Jupiter Medical Center:** Amended the site plan for a major expansion to the surgical center, emergency department and central energy plant at Jupiter Medical Center, located at 1210 Old Dixie Highway.
- **Sea Grape Trimming and Exotic Removal:** Awarded a contract for \$98,842 to K & S Services of South Florida, Inc. for sea grape trimming and exotic removal in designated areas along County Road A1A.
- **Curb Replacements in the Hamptons of Maplewood:** Awarded a contract for \$258,015 to Heavy Civil Inc. to replace curbs in the Hamptons of Maplewood.
- **Town Boards and Committees:** Made appointments to the Town's boards, committees and countywide organizations.
- **Selection of Vice Mayor:** Selected Councilor Cameron May to serve as the Town of Jupiter Vice Mayor for 2021-2022.
- **Street Resurfacing and Roadway Improvements:** Awarded a contract for \$704,593 to J. W. Cheatham, LLC for roadway improvement projects including Jupiter Village Road from Toney Penna Drive to Central Boulevard, Phases 2-7 of Jupiter Village and Stillwater Circle.
- **Public Safety Radio Tower:** Directed staff to move forward with the necessary applications to construct a radio tower to address an area of inconsistent radio coverage in the southeast corner of Jupiter and northern area of Juno Beach.
- **Town Gateway Landscaping and Signage:** Awarded a contract for \$313,606 to A Cut Above Landscape & Maintenance, Inc. to install and maintain landscaping on Indiantown Road at the Turnpike exit and Center Street. Awarded a second contract for \$91,000 to Boromei Construction, Inc. for a Town entry feature sign at the entrance to the Florida Turnpike.
- **Proposed New Town Hall Building:** Reviewed a proposal for a new Town Hall building and overall site plan, and awarded a contract for \$1,357,457 to Song and Associates for architectural and engineering services.
- **MyClinic Expansion:** Approved a 1,433 square foot expansion to the existing MyClinic medical office building located at 411 West Indiantown Road.

- **Neighborhood Matching Grants:** Approved nine grants totaling \$39,872 as part of the 2021 Neighborhood Matching Grant Program.
- **Beach Renourishment Shore Protection Projects:** Approved a 30-year interlocal agreement between the Town of Jupiter and Palm Beach County for beach renourishment projects.
- **Taylor Property Purchase:** Approved the purchase of an 8-acre parcel located at 800 North Delaware Boulevard.
- **Sandpiper Cove:** Approved an amendment to the planned unit development to allow the existing seven Mediterranean multi-family buildings to change the roof material from concrete S-tile to asphalt shingles. The buildings are on almost 46 acres located on the east side of the Military Trail and Indian Creek Parkway intersection.
- **Qualifying Period for Elections:** Approved Ordinance 8-21 to change the qualifying periods for all Town elections to begin at 12:00 noon on the first Tuesday in November and end at 12:00 noon on the third Tuesday of November in the calendar year preceding a Town Election. The change was made to satisfy requirements from the Palm Beach County Supervisor of Elections.
- **Historic Resources Board Membership:** Modified the composition of the Historic Resources Board to include five regular members, two alternate members, adjusted the number of members allowed to be non-resident and layperson, and limited the term for alternate members to one year.
- **Building Heights Standards:** Reviewed sections of the Town's code with respect to building height and discussed possible changes to the standards.
- **South Island Way:** Reviewed the status of plans for an extension of Island Way south of Indiantown Road, and the parcels of land needed in order to construct the project.

#### COMMUNITY REDEVELOPMENT AGENCY (CRA)

- **A1A/Jupiter Beach Road Roundabout:** An update on the budget and schedule for the project was provided by Town Staff. Currently the project is planned to start construction in Fall, 2021 and finish in early 2022.

## Jupiter Receives \$7.5 million from the American Rescue Plan Funding Bill

The Town will receive \$7.5 million from the American Rescue Plan Funding Bill signed in March of this year. The first payment of the funding was received in May while the remainder of the funding will be received in early 2022. The Town Council discussed recommendations on how to utilize the funding at its June 1 meeting as well as at the Thursday, June 24 Budget Workshop and will again at a Budget Workshop on Thursday, August 12.

## Back to School Traffic Safety

School is back in session beginning Tuesday, August 10. To ensure our children safely get to and from school, please remember to drive carefully and follow these traffic safety tips:

- Be aware of school zones and observe the yellow flashing school zone lights and speed limit signs.
- Do not pass a school bus that is stopped to load or unload children.
- Always stop when directed to do so by an officer or a school crossing guard.
- Do not block crosswalks and watch for kids walking.
- **Stay alert while driving and don't text and drive.**

## Public Budget Workshops & Hearings: Fiscal Year 2022

The Town of Jupiter's proposed budget for Fiscal Year 2022, which begins October 1, 2021, will be heard in two public budget hearings tentatively set for Tuesday, September 7 and Tuesday, September 21. Both hearings will be held at 7:00 pm at the Jupiter Town Hall Council Chambers (210 Military Trail). Public budget workshops are held in advance of the public hearings in September. This year, the first workshop was held on Thursday, June 24 and the second is scheduled for Thursday, August 12. ## Town Joins with Palm Beach County for Beach Renourishment Projects

The Town Council approved an interlocal agreement with Palm Beach County for beach renourishment at its May 4 meeting. Under the 30-year agreement, the County will execute beach renourishment projects every seven years and dune restoration every 15 years. The County will be responsible for seeking federal and state funding for the projects while the Town will pay for 10% of costs, not to exceed \$950,000 in the first year of the agreement and \$250,000 a year in each following year, after any federal funds are applied to the total cost of the project. The first renourishment project is scheduled for 2022.

## Public Hearing to Consider Stormwater Fee Increase

At its regular meeting on August 17, the Jupiter Town Council will consider an adjustment to the monthly fee charged for stormwater services (see tables below).

<b>Stormwater Utility Fee (proposed 1.1% increase)</b>	<b>Oct. 1, 2020</b>	<b>Oct. 1, 2021</b>
Average residential monthly stormwater bill	\$6.10/mo.	\$6.17/mo.

Should the proposed rate increases be adopted by Council, new rates would take effect October 1, 2021. Please call 561-741-2300 with any questions you may have.

The proposed adjustment is intended to do the following:

- Enhance stormwater runoff quality to the Loxahatchee River to effectively mitigate existing water quality impairments;
- Minimize the risk of flooding;
- Maintain rates for service consistent with the cost of service; and
- Support the sustainability of the utility's financial plan including funding for renewal and replacement of aging assets.

## Beach Bucket Clean-Up Stations Now Around Town

Looking for a way to help the local environment on your next walk, park visit or trip to the beach? Grab a bucket at one of the Town's new bucket clean-up stations and make your outdoor activities a win for you and the community.

As part of their 2021/2022 Strategic Plan, Town Council identified clean-up activities along waterfront and parks areas as one of their initiatives. In partnership with the Beach Bucket Foundation, the Town installed bucket clean-up stations at four local parks and waterfront areas. Each one of these stations consist of four buckets and a trash can. Visitors can just grab a bucket to pick up litter while they enjoy a walk at the park or on the beach. ## What's That Bulldozer For?

There are a number of construction projects in Jupiter that are underway or will be starting soon. Check out the list below for information on some projects of interest. 1. **322 Center Street:** The adaptive reuse of a locally designated historic structure for a restaurant and retail food establishment. Under construction.
2. **408 Center Street:** The adaptive reuse of a locally designated historic structure for a beauty salon. Under review.
3. **Beacon Park:** A large scale planned unit development for a 57.7 acre industrial parcel of land located on the north and south side of Island Way, west of Limestone Creek Road. Under review.
4. **Beacon Park Hotel:** The construction of a 120 room hotel with conference rooms located on the south side of Island Way north of Indiantown Road. Under review.
5. **Bear's Club:** The enclosure of 800 square feet of an existing dining room patio at the clubhouse located at 250 Bears Club Drive. Under review.
6. **Concourse Plaza:** The addition of outdoor seating and changing 3,318 square feet of retail space to a 2,118 square foot restaurant and 1,200 square feet of indoor recreation space on an 11.49 acre property located at 131 Alternate A1A. Approved.
7. **Cornerstone:** A planned mixed use building including 15 residential units and retail space located at 50 S. U.S. Highway One. Under construction.
8. **Dune Dog:** The demolition of an existing warehouse and construction of a four-story retail/office building that includes the addition of a walk-up food service building and covered and outdoor seating areas at the existing Dune Dog restaurant on 3.0 acres located at 775 N. Alternate A1A. Under review.
9. **Jupiter Medical Center:** A major expansion to the surgical center, emergency department and central energy plant on a 27.3 acre property located at 1240 Old Dixie. Approved
10. **Maltz Theatre:** The expansion of the existing theater on a 4.8 acre property located at 1001 E. Indiantown Road. Under construction.
11. **Orion Integrated Systems:** The construction of a 7,100 square foot office and industrial building

on a 0.47 acre vacant property and a business office greater than 2,500 square feet located on the east side of Capital Street north of Jupiter Park Drive within the Jupiter Commerce Center. Approved.

12. **Pink House:** Allowing retail and medical office use on a 0.25 acre property located at 1011 Love Street. The exterior appearance of the structure will remain as-is with a different color. Also, there will be updates to the landscaping. Under construction.
13. **Spetter:** The construction of a two-story building with 1,225 square feet of office space and 5,160 square feet of warehouse on a 0.47 acre property located on the east side of Capital Street north of Jupiter Park Drive within the Jupiter Commerce Park. Approved.
14. **Water Pointe:** An increase in size of residential units, inclusion of two car garages and optional half stories and a change in architectural style from Mediterranean to Florida Cracker. Also, the construction of a 4.2 acre pocket park located on the west side of U.S. Highway One, north of the intersection of U.S. Highway One and Ocean Way. Approved.

## Town Purchases the “Taylor Property”

At its May 4 meeting, the Town Council approved the purchase of the “Taylor Property,” located at 500 North Delaware Boulevard, for \$3.3 million. The 7.88 acre property will be utilized as open green space. The purchase was made possible through a 2019 voter-approved bond that is to be utilized to acquire lands to be used as open spaces, traffic mitigation and recreational space.

## Sales Tax Holidays Announced

The State of Florida has announced two sales tax holidays for the upcoming months. Freedom Week Tax Holiday, July 1-7: The first ever “Freedom Week” provides seven days of sales tax savings on outdoor recreation purchases, such as the first \$100 of the sales price of sunglasses, the first \$200 of the sales price of tents and the first \$500 of the sales prices of kayaks and canoes. Additionally, the tax holiday applies to tickets for events, museums, the arts and more. Back-to-School Sales Tax Holiday, July 31-August 9: Pay no sales tax for certain clothing of \$60 or less per item, school supplies of \$15 or less per item and the first \$1,000 of personal computers and related accessories during this 10-day tax holiday. ## Homestead Exemption Outreach

September 8 • October 13 • November 10 • December 8

- Floridians know that something unique about living in a state where so many people love to vacation is the Homestead Exemption that is filed with your property taxes. Although this exemption only needs to be filed once for each property and will then carry over annually, it is important for first-time filers to know the requirements and deadlines for this tax exemption that can significantly reduce your property tax.
- Staff from the Palm Beach County Property Appraiser’s Office, Division of Education Services, will be on-hand at the Jupiter Community Center at dedicated times September through December to help you submit your Homestead Exemption application and answer any property valuation questions you may have. If you are looking for Homestead Exemption assistance, plan to attend any one of the following sessions: 2 to 3 pm on September 8, October 13, November 10 and December 8. All sessions will be held in the

- Jupiter Community Center (200 Military Trail, Jupiter FL 33458).
- Some helpful information to know about the Homestead Exemption is you must hold the legal title to a residential property by January 1 of the application year, and the property for which you are seeking exemption must be your primary, permanent residence. You also must be a legal resident of Florida by January 1 of the initial application year.
  - There are also different types of Homestead Exemptions that can be applied for, including; the up to \$25,000 Homestead Exemption; the additional \$25,000 Homestead Exemption; a Senior Citizen Exemption; a \$5,000 Disabled Veterans Exemption; a Combat-disabled Senior Veterans Exemption; and a \$500 Widow/Widower Exemption.
  - Applications are accepted by mail or in-person at any time throughout the year, but in order for the exemption to be considered for the upcoming tax year, the application must be received by March 1 of the qualifying year. A copy of your deed and proof of residency is required for filing. For proof of residency, you may submit a copy of your Florida driver's license, voter registration or permanent residency card. In lieu of a pending permanent resident alien card, the Federal Form I485, "Approval Notice for Application to adjust to Permanent Residential Status," is accepted.

## Be a Good Neighbor – Mind Your Parking!

The Town of Jupiter updated its parking regulations in 2012 to address a number of parking issues that were of concern to the Town and its residents. As a reminder, regulations are in force in Jupiter that clarify what is permitted when parking passenger cars, trucks, boats, trailers or recreational vehicles in the front, side, side corner or rear yards or in swales.

- Practicing proper parking will not only keep you from being cited, but will provide a safer environment for pedestrians and cyclists. For instance, a vehicle is improperly parked over a sidewalk if pedestrians must walk into a street to get around it. Improper parking may impact bike safety and child safety, and create hazards for individuals with mobility limitations.
- Residents should also be aware that vehicles parked on front yards have the potential to block the visibility of the front door of a home or limit the emergency access to a home.
- Additionally, it is also a violation to park cars or recreational vehicles overnight in a public right of way, such as along A1A.
- So be a good neighbor and be sure to properly park your cars, boats and recreational vehicles. You'll avoid a ticket and you'll be doing your part to help increase the safety of our streets and neighborhoods.

## Water Plant Operator Receives Award

On June 8, Water Plant Operator A Mike Houtz was honored with the Outstanding Senior Operator Award by the Southeast Desalting Association (SEDA). ## 2021 Matching Grant Recipients

On May 4, Town Council approved \$39,872 in Neighborhood Matching Grants to nine different neighborhood groups throughout Jupiter. Neighborhood Matching Grants are awarded every year and are intended for visible neighborhood improvements or security enhancements. Matching grants leverage private funding by requiring a 50% match, which can consist of cash, donated material or labor. Each grant award can be as much as \$5,000. ## Ask the Expert: Steps to Prevent Stormwater Flooding

With the rainy season upon the South Florida area, the focus on stormwater and drainage maintenance is important to prevent flooding of Town streets, businesses and homes. We spoke with Dave Rotar, Stormwater Utility Coordinator to learn more about how residents can help prevent flooding.

**Q: What comprises the stormwater system in the Town of Jupiter?**

A: The stormwater system consists of drainage structures (inlets), pipes, swales, exfiltration trenches, both wet and dry detention ponds, and pump stations.

**Q: How does stormwater differ from wastewater?**

A: Wastewater (also referred to as sewer water) is the water that leaves a home's or business' plumbing system and is carried by a network of pipes to the wastewater treatment plant.

Stormwater is created as the result of rainfall. The rain water that is not absorbed into the ground becomes surface runoff which flows into nearby stormwater drains and into surface waterways.

**Q: Does stormwater undergo any treatment before being discharged from the Town of Jupiter system?**

A: Stormwater does receive some treatment before being discharged into the canals, creeks,

Intracoastal Waterway and Loxahatchee River. Treatment occurs naturally in swales, detention ponds and exfiltration trenches when the rate of flow of the runoff is reduced allowing pollutants to settle and be removed prior to discharging to receiving waters. Grassed swales also help to filter the rainwater and remove sediments, heavy metals and hydrocarbons such as oil and grease.

Meanwhile, exfiltration systems and detention ponds are effective in removing excessive nutrients in runoff. Exfiltration trenches help to slow down the flow of the stormwater in the pipes and also provide some storage of the runoff. Within exfiltration trenches, water is allowed to seep into the soil surrounding the trench which helps with treatment of the stormwater and recharges the groundwater in the area.

In a natural stream or wetland, nutrients can cause problems by encouraging too much plant growth. Plants in the wet detention ponds use these same nutrients to fuel growth, so fewer of these pollutants enter the natural streams and wetlands. Insects and micro-organisms living in the pond's mud can also help remove pollutants from the stormwater. Detention ponds are maintained to control vegetative growth and periodically remove accumulated sediment.

**Q: Does stormwater discharge cause algae blooms in the Loxahatchee River or any of our other water assets?**

A: The Town of Jupiter and the surrounding municipalities have been very fortunate that algae blooms have not occurred in the Loxahatchee River. Our river's watershed is not directly connected to Lake Okeechobee or other areas with nutrient impaired runoff. However, there is always a potential for algae blooms, which is why the Town has taken steps to help reduce this possibility by constructing stormwater treatment systems, actively maintaining drainage systems and implementing other best management practices such as limiting nutrient-containing fertilizer use during the rainy season.

**Q: What does the Town of Jupiter do to help mitigate flooding?**

A: The Town of Jupiter's Stormwater Utility actively inspects major outfalls and drainage structures before and after a large rainfall event. We also maintain the pump stations and drainage systems owned by the Town. With the forecasted effects of climate change and sea level rise, the Town also has begun to implement adaptation measures to minimize impacts to low-lying areas effected by tides. In many areas, the utility has begun to install check valves in the drainage system to help keep the rising tide from flowing backward from the river and Intracoastal Waterway into the drainage system.

**Q: What can residents do to help mitigate flooding on their property?**

A: Residents can help by ensuring the swale areas along their properties and stormwater structures are not blocked or covered by yard waste so that these systems can function properly. When we have a large rainfall event and residents notice that a storm drain is not draining the water, they can rake any debris off of the inlet structures. Homeowners also need to ensure that any plantings, driveway modifications or other improvements do not impede runoff or its conveyance to outfalls and should also make sure that downspouts direct the water from the roof away from the home.

**Q: Outside of helping to prevent flooding, are there any other benefits to the stormwater efforts of both the Town and residents?**

A: Working together we can minimize the risk of flooding through maintenance of our drainage systems while also collectively striving to enhance the quality of stormwater reaching local waters such as the Loxahatchee River. Residents should continually be aware of the potential harm that any pollutant entering the stormwater system may have on our local waterways. Of course if there are any concerns

or further questions, our Stormwater Utility staff is ready to assist. Residents and business owners should not hesitate to call on us for assistance at (561) 741-2705.
