



## Town Council & CRA Corner: Recent Policy Actions

Below is a summary of some of the approvals and decisions made by the Town Council and the Community Redevelopment Agency (CRA) during recent meetings. - **Preliminary Tax Rate:** Approved the preliminary tax or millage rate (TRIM) for Fiscal Year 2022, which begins Friday, October 1, 2021. The preliminary tax rate is the rate that the Property Tax Collector's Office will include for the Jupiter portion of the preliminary property tax notices mailed out in August. The proposed tax rate for Fiscal Year 2022 is equal to the 2021 millage rate of 2.4633 mills (excluding the debt service millage of 0.1693 mills).
- **Olympian Zion Wright:** Issued a proclamation recognizing Jupiter's Zion Wright for qualifying for the Tokyo Olympics in skateboarding.
- **FAU John D. MacArthur Campus Development Agreement:** Approved an amendment to the existing campus development agreement with the FAU Board of Trustees to extend the expiration date to June 1, 2022.
- **JHS Criminal Justice Academy:** Approved the use of state forfeiture funds for a donation to the Jupiter Community High School Criminal Justice Academy in the amount of \$1,500.
- **Longshore Drive and Northfork Drive:** Approved the transfer of jurisdictional control and right-of-way ownership of Longshore Drive and Northfork Drive from Palm Beach County to the Town of Jupiter.
- **General Obligation and 2021 Land Acquisition Bond Financing:** Approved the lender for the refinancing of the Town's Series 2005 General Obligation Bonds and issuing of Original Issue 2021 Land Acquisition financing, which will be used for the purchase of the Taylor Property.
- **Indiantown Road from U.S. Highway 1 to A1A:** Approved a Local Agency Program (LAP) agreement with the Florida Department of Transportation (FDOT) for Indiantown Road from U.S. Highway 1 to A1A.
- **Security Camera Replacement:** Approved a contract with Accelerated Technologies for security camera replacement and upgrades at the Jupiter Community Center in the amount of \$68,198.
- **Indiantown Road Raw Water Main Construction:** Approved a contract for \$699,679 with Accurate Drilling Systems, Inc. for the construction of a raw water main that will cross under Indiantown Road.
- **Water Utilities Storage and Dosing System:** Approved a contract with Car Eric Johnson Inc. (CEJCO) for the supply and installation of a sodium hypochlorite storage and dosing system in the amount of \$131,988.
- **Police Department Radio Pole:** Approved a Special Exception and Site Plan application for a radio pole with a waiver to setbacks located on a 0.8 acre property on the northwest corner of the public parking lot at Marcinski Road and A1A. The pole will improve radio communication coverage for first responders in the area.
- **322 Center Street (The Sims House) Historic Preservation Grant:** Approved a Historic Preservation Grant Program application request in the amount of \$50,000 for partial reimbursement of the acquisition price of the house with no conditions.
- **Generation Church Historic Preservation Grant:** Approved a Historic Preservation Grant Program application request in the amount of \$98,890 for partial reimbursement of the acquisition price of the circa 1924 historically designated People's Congregational Church at 430 Center Street with no conditions.
- **New Town Hall Construction Management Services Contract:** Approved a contract amendment for \$1,357,457 with Kaufman Lynn to include construction management services for the proposed new Town Hall project.
- **American Rescue Plan Act (ARPA) Funds:** Accepted ARPA funds in the amount of \$3,795,479 and approved the use of the funds for the Seminole Avenue Stormwater Basin Improvements project.

### Town and CRA adopt millage rate, operating budgets and 5-year Community Investment Programs (CIP)

**Fiscal Year 2022 begins October 1, 2021 and ends September 30, 2022**

On September 23, the Town Council adopted the millage (property tax) rate, operating budget, pay plan for FY2022, and the five-year Community Investment Program (CIP) for FY2022- 2026. The millage rate for FY2022 is 2.4633, not including debt; including voter-approved debt service, the total millage rate for FY2022 is 2.6326. The FY2022 millage rate, which is stated in terms of dollars per \$1,000 of taxable property value, is 0.0198 mils less than the combined rate for FY2021. The FY2022 Operating Budget and Pay Plan for all Town of Jupiter funds for the fiscal year ending September 30, 2022 totals \$135 million including debt service funds. This represents a \$26 million increase from the prior fiscal year, which had a total budget of \$108 million. The primary reason for this increase is restrictions in state shared revenue reductions from the COVID-19 pandemic in FY2021. The FY2022- 2026 five-year CIP expenditures total \$32 million compared to \$7.2 million for fiscal years 2021-2025. This represents a \$24.7 million increase in the current proposed CIP from the prior year adopted total. This increase is predominately made up of \$18.1 million for the construction of the new Town Hall facility, and \$1.9 million for beach renourishment funds.

On September 7, the CRA Commission adopted the FY2022 operating budget and five-year CIP for the Community Redevelopment Agency. The CRA operating budget for FY2022 totals \$2,437,622, a decrease of \$240,747 over FY2021. The five-year CIP for FY2022-2026 totals \$250,000. Major capital projects in the CIP include improvements to the intersection of A1A and Beach Road.

### Stormwater Fee Increase Beginning October 1

On Friday, October 1, residents will see a 1.1 percent increase in their stormwater fee included on their monthly utility bill. The increase is based on the U.S. Department of Labor's Consumer Price Index (CPI) and ensures adequate funding for rehabilitation and replacement of utility assets and capital improvements intended to enhance runoff water quality to the Loxahatchee River. The typical residential customer's monthly stormwater utility fee will increase from \$6.10 to \$6.17, an increase of \$0.07.

## Waste Management Services Rate Increases Beginning October 1

Effective Friday, October 1, rates for waste management will increase by 5 percent over the previous fiscal year (see rates comparison in the table below). Residents will see the slight increase reflected in their October utility bill statement.

October bills will be prorated with the number of days in the cycle from the previous September bill date through September 30 billed at the previous rate, and from October 1 to the current date in October billed at the new rate. The

November bill will reflect a full month of the new rate. These adjustments are intended to maintain fees consistent with industry-wide rates in accordance with the Consumer Price Index (CPI). Please call 561-741-2467 with any questions.

## Homestead Exemption Outreach October 13 • November 10 • December 8

Floridians know that something unique about living in a state where so many people love to vacation is the Homestead Exemption that is filed with residents' property taxes. Although this exemption only needs to be filed once for a permanent residence and will then carry over annually, it is important for first-time filers to know the requirements and deadlines for this tax exemption that can significantly reduce their property tax.

Staff from the Palm Beach County Property Appraiser's Office, will be on-hand at the Jupiter Community Center (210 Military Trail) from 2:00 to 3:00 pm on October 13, November 10 and December 8 to help residents submit their Homestead Exemption application and answer any property valuation questions residents may have.

### Additional Homestead Exemption Approved for Income-Qualified Senior Citizens

During a Special Meeting on August 5, the Town Council authorized Ordinance 12-21, which allows for an additional homestead exemption to certain income-qualified senior citizens living in the Town of Jupiter. The maximum additional homestead exemption is up to \$50,000. The exemption would apply to fiscal year 2023 taxes.



## Jupiter Celebrates Florida City Government Week

October 18-24 is Florida City Government Week, celebrating, showcasing and engaging citizens in the work of municipal government. ### Town Code Occupancy Limitations

There are many multigenerational and multi-family homes throughout Jupiter. As more people start to occupy a dwelling, it is important to remember and follow Town Code Section 21-171 relating to occupancy limitations.

- A single-person bedroom must have at least 70 square feet of space, and a shared bedroom must have at least 50 square feet of space per adult. The Town's goal is not to displace any families, so this portion of the code is not required for minors.
- Only bedrooms should be used as permanent sleeping spaces in a home.
- Every home should be equipped with at least one toilet and tub or shower for every six adults that live there.
- Accessory structures, such as sheds, must not be used as dwellings unless the use is permitted and approved by the town.
- Vehicles, boats and recreational vehicles also can't be used as dwellings.

The failure of any of these code requirements can lead to the dwelling unit being deemed a public health, safety and general welfare threat.

## Business Tax Receipt Eliminated



During its August 17 meeting, the Town Council voted to repeal the section of the Town Code that established the Town's Business Tax Receipts. With this repeal, businesses in the Town of Jupiter are no longer required to apply for or renew their business licenses with the Town.

Palm Beach County Local Business Tax Receipts will still be required of all current and new businesses located within the Town of Jupiter. Existing businesses should renew with the County by September 30 of each year and new businesses should submit applications online at [www.pbctax.com](http://www.pbctax.com) under the "Local Business Tax" button.

## New Roundabout Coming to Jupiter Beach Road and A1A

Construction of a new roundabout at Jupiter Beach Road and A1A will begin soon after the start of 2022. During construction, access to existing driveways and Jupiter Beach Road will be maintained. Detours to local traffic are anticipated, but will be limited to a period of construction for an underground storm water pipe. Access for residents, fire rescue and the Town's Police will be maintained throughout the construction.

## Code Complaints Can No Longer be Anonymous

In July, the Florida Legislature passed Senate Bill 60, which prohibits municipal code enforcement from initiating investigations of potential violations of codes and ordinances through anonymous complaints. Under the bill, the complainant must provide his or her name and address before an investigation occurs. The new law doesn't apply to code compliance officers if they have a reason to believe that the violation presents an imminent threat to public health, safety or welfare of individuals; or an imminent destruction of habitat or sensitive resources.

## Navigating the "Peanut" Roundabout at Central and University

In May, Palm Beach County finished construction on the new roundabout at the intersection of University Boulevard and Central Boulevard. The new traffic pattern gets its "peanut" name from its elongated, figure-eight shape. It was constructed to help improve traffic flow, reduce accidents, and make a safer environment for pedestrians and bicyclists. But as with any new traffic pattern, this roundabout can confuse even the most seasoned driver.

Despite this intersection's unique shape, it operates the same as a circular roundabout. There are four entrances into the roundabout – north and southbound lanes on Central Boulevard and east and westbound lanes on University Boulevard. When cars approach the intersection from any of these entrances, they must yield to vehicles already in the peanut-shaped loop. Each of the entrances also has a yield sign to direct drivers. Vehicles then travel in a counter-clockwise direction until they reach their exit.

### Quick tips for navigating the roundabout:

- Do turn right to enter the roundabout. The roundabout is one way.
- Do yield to traffic that is already in the roundabout.
- Do travel around the roundabout counter-clockwise.
- Do use your turn signal before exiting the roundabout.
- Do exit the roundabout from the right lane.
- Don't stop when you are in the roundabout.



## Community Development Block Grant Program

Each year, the Town of Jupiter receives approximately \$300,000 in federal funds from the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) Program. The funds are meant to help address the community development and housing needs within the municipal limits of the Town by achieving the overall goal of decent housing, a suitable living environment and expanded economic development opportunities primarily for low- and moderate-income persons.

The Town hosted two public meetings this past summer to seek input from residents for projects and is proposing to utilize the 2021-22 funds to improve safety, including but not limited to enhanced pedestrian crossings, on South Loxahatchee Drive in the Pine Gardens South neighborhood.

In the past, the Town of Jupiter has used these funds for capital improvement projects (water mains and drainage improvements), park and playground renovations, athletic scholarships for youth, rehabilitation of homes, and emergency financial assistance.

## Seminole Avenue Stormwater Basin Improvements Set to Begin

On September 9, the Town Council approved the use of \$3,499,869 of the Town's allotment from the American Rescue Plan Act (ARPA) for the construction of the Juno Street Stormwater Pump Station. The project is part of the Town's Seminole Avenue Stormwater Basin Improvement Capital Investment Plan (CIP). The new stormwater pump station will be located on Old Dixie Highway between Juno Street and Venus Street with an outfall to the FEC Canal on the east side of Alternate A1A. The Seminole Basin is located in an older, low-lying section of Town made up of predominantly commercial-industrial land use with small residential areas. The existing pump station that currently serves the Seminole Basin is located on Seminole Avenue, north of Center Street, and is unable to meet the demand of the Basin during heavy storms, which often times results in significant flooding on Center Street and the surrounding areas. The Juno Street Pump Station will alleviate flooding in the Seminole Basin by reducing load placed on the Seminole Avenue Pump Station, which discharges to the Loxahatchee River. Enhancement of stormwater quality discharged to the Loxahatchee River and the Intracoastal Waterway will also be provided by this project.

## Ask the Expert: U.S. Highway 1 Bridge Replacement Project

The U.S. 1 Bridge Replacement Project began in late September with improvements to various intersections in Town. Over the last couple years, residents may have heard about this project, which is aimed at replacing the current bridge over the Jupiter Inlet. We spoke with Angel Streeter Gardner, the Community Outreach Specialist for the project, to discuss an upcoming timeline.

### 1. What work relating to the U.S. 1 Bridge Replacement Project is ongoing? And what work is expected in the near future?

Construction on the U.S. 1 Bridge Replacement Project began September 25. This initial phase includes adding turn lanes at the following intersections along the detour route: U.S. 1 and Indiantown Road, Alternate A1A and Indiantown Road, and U.S. 1 and Alternate A1A/South Beach Road. Improvements will also occur at Alternate A1A and Old Dixie Highway consisting of shifting the intersection to the southwest, adding a traffic signal and lengthening the left-turn lane from northbound Alternate A1A to northbound Old Dixie Highway. In addition, traffic monitoring devices will be installed along these corridors and intersections. Minor bridge repairs will occur on the Alternate A1A Bridge over the Loxahatchee River. Also, work will begin on installing the foundations for the replacement bridge.

### 2. How will this first phase of work impact residents?

Impact to residents is anticipated to be minimal during the first phase. Nighttime lane closures will occur from 9:30 pm to 6:30 am Sunday through Saturday on U.S. 1, Indiantown Road, Alternate A1A, Old Dixie Highway and South Beach Road. Residents near the bridge should anticipate heightened noise levels during pile driving activities, which will occur during daytime hours.

### 3. Why is this work necessary ahead of the U.S. 1 bridge replacement?

The initial intersection improvements are designed to keep traffic flowing and lessen impacts to the traveling public when the U.S. 1 bridge is closed and traffic is detoured to Alternate A1A. Traffic monitoring devices will allow the Florida Department of Transportation (FDOT) and Palm Beach County to continuously monitor and actively manage the traffic along the detour route.

### 4. When will the bridge be closed for construction?

The bridge will close for approximately 20 months beginning in spring 2023.
