A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF JUPITER, FLORIDA, CERTIFYING THE RESULTS OF THE REGULAR ELECTION HELD ON MARCH 11, 2008 FOR TOWN COUNCIL.

Robert M. Friedman having received a majority of votes cast, is hereby declared elected to said office.

<u>Section 2.</u> The foregoing tabulation of the votes cast is hereby certified as the results of the regular election.

<u>Section 3.</u> The Town Clerk is directed to send a certified copy of this Resolution to the Supervisor of Elections of Palm Beach County, and to post a copy for public notice.
