STIPULATION AND AGREED ORDER FOR FINE ABATEMENT

The Petitioner, TOWN OF JUPITER, and the Respondent, **Capital C Inc. and James Corey Crowley, R.A.** by and through their undersigned agent, hereby file this stipulation and state:

1. The parties agree to resolution of the existing code enforcement fines and liens for case numbers 20-1025 and 20-1276.
2. The property's address is 703 Iroquois St., Jupiter, FL.
3. The Petitioner, Town of Jupiter (Town) has agreed to accept a total payment in the amount of \$3,000.00 to settle all code enforcement fines and liens in the above referenced cases. Payment must be received by the Town's Code Compliance Office within 30 days of execution of the Agreed Order by the Town's Magistrate.
4. Failure to comply by the specified due date will result in the fine for **case 20-001025** reverting to its full and original amount of \$88,400.00
5. Failure to comply by the specified due date will result in the fine for **case 20-001276** reverting to its full and original amount of \$15,300.00.

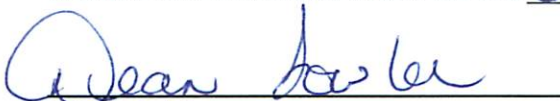
